PLEASE TAKE NOTICE that AMR NOMAN, hereby makes claim against the CITY

OF BUFFALO, CITY OF BUFFALO DEPARTMENT of PUBLIC WORKS CITY OF

BUFFALO FIRE DEPARTMENT, and ERIE COUNTY WATER AUTHORITY in support
thereof Claimant alleges:

- 1. That the undersigned Claimant, AMR NOMAN, residing at 4273 Bailey Avenue,
 Amherst, NY 14226, by and through his attorney, Brendan M. Denz, Esq, WILLIAM MATTAR,
 P.C., 6720 Main Street, Suite 100, Williamsville, NY 14221-5986, claims damages against the
 CITY OF BUFFALO, CITY OF BUFFALO DEPARTMENT of PUBLIC WORKS, and the
 CITY OF BUFFALO FIRE DEPARTMENT, and ERIE COUNTY WATER AUTHORITY,
 for personal injuries, pain and suffering, general and special damages, medical expenses, and
 property damages sustained by him.
- 2. That the said injuries were sustained by AMR NOMAN on December 13, 2023 at approximately 7:47 a.m at the traffic light in front of 3495 Bailey Avenue in the City of Buffalo, County of Eric and State of New York. See Exhibit "A", the MVA-104 attached hereto.
- 3. On that day and approximate time, Mr. Noman was stopped in his motor vehicle at a redlight when suddenly and without warning was struck in the rear-end by a vehicle owned and operated by David V. Tower, which was unable to stop due to ice on the roadway caused by a malfunctioning fire hydrant in close proximity to the crash. *See* Exhibit "B"
- 4. That Claimant, AMR NOMAN, damages and injuries occurred as a result of the negligence, carelessness, and reckless disregard for the safety of others by Respondents, the CITY of BUFFALO, CITY OF BUFFALO DEPARTMENT OF PUBLIC WORKS, CITY of BUFFALO FIRE DEPARTMENT, and ERIE COUNTY WATER AUTHORITY and/or their servants, agents or employees in negligently maintaining, operating, remediating, and/or installing an improperly functioning fire hydrant and fire hydrant water lines, causing water and ice to build up on the

roadway causing a dangerous defect and did not put down salt to prevent ice. The Fire Hydrant is located in front of the VA Hospital Bus Stop in close proximity to the location of this crash. See Exhibit "C"

- 5. Upon information and belief, the fire hydrant was controlled, operated, owned and maintained by the CITY of BUFFALO.
- 6. Upon information and belief, the fire hydrant and connecting pipes were controlled, operated, owned and maintained by the CITY of BUFFALO FIRE DEPARTMENT.
- 7. Upon information and Belief, the fire hydrant was controlled, operated, owned, and maintained by the CITY of BUFFALO DEPARTMENT OF PUBLIC WORKS
- 8.. Upon Information and belief, the fire hydrant and connecting pipes were controlled, operated, owned and maintained by the ERIE COUNTY WATER AUTHORITY.
- 9. That Claimant, AMR NOMAN, damages and injuries occurred as a result of the negligence, carelessness, and reckless disregard for the safety of others by Respondents, the CITY of BUFFALO, CITY OF BUFFALO DEPARTMENT OF PUBLIC WORKS, CITY of BUFFALO FIRE DEPARTMENT, and the ERIE COUNTY WATER AUTHORITY and/or their servants, agents or employees in negligently maintaining, operating, remediating, and/or installing an improperly functioning fire hydrant and water piping leading to the fire hydrant, causing water and ice to build up on the roadway near a bus stop and traffic light.
- 10. That the aforesaid CITY OF BUFFALO, CITY OF BUFFALO DEPARTMENT of PUBLIC WORKS, CITY of BUFFALO FIRE DEPARTMENT, and the ERIE COUNTY WATER AUTHORITY by and through his agents, servants and employees had actual or constructive notice

of the malfunctioning fire hydrant, and the dangerous condition and hazard caused by said activity and that their negligence would foreseeably result injury to others, including Claimant.

11. That as a result of the foregoing, the Claimant, AMR NOMAN, suffered serious and

permanent injuries to his head, neck, back, shoulders and knees, of indefinite duration, and

Claimant, AMR NOMAN, has and will, in the future be forced to expend sums of money for

hospitals, doctors and other medical expenses.

12. That the said injuries were caused wholly or in part as a result of the negligence of

CITY of BUFFALO, CITY OF BUFFALO DEPARTMENT of PUBLIC WORKS, CITY OF

BUFFALO FIRE DEPARTMENT, and the ERIE COUNTY WATER AUTHORITY and through

his agents, servants and employees and without any negligence on the part of the Claimant

contributing thereto.

WHEREFORE, Claimant requests that his claim be allowed and paid by Respondent.

PLEASE TAKE FURTHER NOTICE that unless a hearing under General Municipal Law §50 is

requested by Respondent within ninety (90) days from the date of service of this Notice of Claim,

said Claimant fully intends to commence an action in Supreme Court of the State of New York

against Respondent for a sum which exceeds the jurisdictional limits of all lower courts which

would otherwise have jurisdiction, together with interest, costs, and disbursements.


