#### C. FISCAL

#### 1. Barcoding and Scanning Initiative

Lavonya Lester gave an update on the Barcoding and Scanning Initiative including the results of the RFP process. The Review Committee discovered after evaluating the submissions and the vendor demonstrations that the tasks required were well within the Authority personnel's capabilities. Therefore, Ms. Lester and the Review Committee recommend allowing internal staff to complete the Barcoding and Scanning Initiative. Ms. Lester noted that the Authority's current software is compatible with the project and the only expense will be the purchase of the hardware. The benefits of the project include reduction of inventory losses and real time inventory reconciliation. Chairman Schad requested the Board receive a copy the implementation plan and schedule with periodic updates.

Joyce Tomaka distributed the February 2024 Investment Report along with a brief explanation of the report.

Jessica Brown distributed the February 2024 Monthly Financial Report and briefly reviewed the data.

#### 1. Lead & Copper Reduced Monitoring

Sabrina Figler gave a brief overview of the history of the Authority's LCR Monitoring. Ms. Figler informed the Board that NYSDOH has returned the Authority to Reduced Lead and Copper Monitoring under the current LCR. Ms. Figler described the testing process. A discussion occurred regarding the benefits of reliable in-house testing versus outside private, testing services.

#### 2. Project Advertised for Bidding – Formal Contract

Leonard Kowalski reported on two projects advertised for bidding since the last Board Meeting: Excavated Material Removal and Disposal 2024 through 2026, PN 202400027 and Industrial Blasting, Painting and Associated Maintenance Contract PN 202400038.

#### 3. PFAS Testing Update

Secretary McCracken informed the Board of an additional update from Sabrina Figler regarding PFOS and PFOA. Ms. Figler discussed the EPA's announcement of National PFAS Drinking Water Standard and the Authority's history and level of preparedness. The EPA announcement included new federal standards for PFAS in drinking water. Ms. Figler noted that she anticipates an announcement from NYSDEC expanding on the federal limits. Ms. Figler reported that the Authority's drinking water levels are well below the new federal MCL of 4.0 ppt and the Authority will continue to comply with all state and federal regulations and continue to monitor for an additional 23 compounds quarterly. Chair Schad inquired as to our effort to quantify a possible future change in our filtration process that could remove the PFAS and PFOS substances. Executive Engineer Kowalski reported that staff is currently developing a specification for a global assessment of the scope of such a project.
