**WHEREAS,** based upon an examination of 6 NYCRR § 617.4 and § 617.5, the Authority classified the Project as an Unlisted Action given § 617.2(al) and a Short Environmental Assessment Form ("EAF") was prepared for the Project;

### NOW THEREFORE BE IT RESOLVED AS FOLLOWS:

That the Authority's Board of Commissioners (the "Board") hereby makes the following findings:

The Project consists of the development of additional property for residuals drying which will occur near SPWTP's existing residuals drying bed area. The project scope will include clearing and other site work associated with the construction of an approximately 0.98-acre expansion; and be it further

Based upon review by the Board of the EAF and other necessary criteria set forth in SEQRA, the Board hereby finds and determines the following: (a) the action is not one which "may include the potential for at least one significant adverse environmental impact," (b) "there will be no significant adverse environmental impacts," and (c) no "environmental impact statement" need be prepared, as such quoted terms are defined in SEQRA. In summary, the Project will result in no significant impacts and therefore, this determination constitutes a negative declaration for purposes of SEQRA and it has been prepared in accordance with Article 8 of the Environmental Conservation Law.
- 3. The Authority's Executive Engineer Leonard F. Kowalski is authorized to sign the attached EAF as well as any other pertinent documents related to the SEQR process and to file this Negative Declaration, as necessary, in accordance with the applicable provisions of the law.
- 4. A copy of this resolution, together with notice of negative declaration, shall be placed on file in the office of the Authority, 3030 Union Road, Cheektowaga, New York where the same shall be available for public inspection during business hours and such notice of negative declaration shall be filed in such offices, posted in such places and published in such manner as shall be necessary to conform to the requirements of SEQRA.
