1. Masiello Martucci Hughes – Lobbying Update

Secretary McCracken began the conversation by commending Chair Schad for his endeavors to engage local congregations in raising funds to support the LCRR mandates. Vic Martucci of the Authority's lobbying firm, Masiello, Martucci, Hughes, provided the Board an outline of their lobbying objectives for the upcoming year. Mr. Martucci provided insights into the New York State budget procedures and detailed the Authority's lobbying initiatives. The discussion included Senate Bill No. 1850A which establishes the Safe Water and Infrastructure Action Program ("SWAP"). Mr. Martucci informed the Board that public authority-funded drinking water was included in the bill. Mr. Martucci indicated another objective is to provide letters of support from the Board to the Western New York Delegation for Article VII budget language to establish SWAP. Mr. Martucci also proposed more frequent meetings be arranged between Masiello, Martucci, Hughes and the Authority to maintain continuous communication.

Commissioner LaGree requested Mr. Martucci to continue promoting language and formula changes within the EFC grants. Mr. Martucci stated that they would remain persistent. Chair Schad asked if there might be another individual, aside from a Legislator, who could effectively assist in promoting the changes to the EFC grant. Mr. Martucci recommended starting discussions with the Governor's Deputy Secretary for Energy and Environment and the Division of Budget.
