The EC Water Authority came out in mid February 2025 to repair a leaking water line under apron of driveway. There

was some significant ground shaking for several minutes to break up the concrete driveway on the left side of driveway. I had checked around the house afterwards out of concern that something may get damaged from the activity as there

are some sensitive areas or ceramics on shelves. Initially I did not notice any damage, however in the days that

followed I did notice the very front closet door nearest to where this repair work was done failed to go inside the frame

of the door whatsoever. I tried replacing the hinges as a possible solution and this step did not work. My conclusion

-based on history of the house and the activity outside is the door frame likely shifted enough to prevent door fromclosing (21 years of living at this location). I have only estimated the cost for the moment to be around \$100 to repair

the door, however the cost can run higher depending on if the door needs more significant adjustments like being

planed by a professional. I am sorry to bring the matter to your attention, if I felt the house shifted or it was summer

where wood sometimes "swells" I would probably discount the possibility of the water repair being to blame, however, this issue did coincide with the repair so I am assuming this activity did cause the problem unfortunately.
