Also, a copy of SEQRA, documentation if required for the project and its design and implementation, which includes the removal of trees and vegetation.

This request includes all correspondence, contracts, internal memos, phone conversations, audio, reports statements, examinations, department or other memoranda, opinions, folders, files, notes, pamphlets, photographs letters, transmittal slips and other papers.
