In order to reach the leaking water line, ECWA had to first remove a tree on that property between the sidewalk and curb. They did so by parking a high-lift on my driveway and digging up and removing the tree from this position. After removing the tree ECWA was then able to reach and repair the water line. That night an ECWA employee indicated that all of the dirt, mud and debris would be cleaned up and this seemed to be the case the following morning. However, a few days later, I noticed that my driveway looked eroded or "sunken in" which was not the case before the ECWA performed this work. It actually appears to have "bowed" either by the leaking water line itself, or by the manner in which the ECWA removed the tree on my neighbor's property and repaired the water line. In any event, added to the fact that this portion of McKinley Parkway is a high-traffic area, I am concerned that the damage to my property will only worsen over time.

Upon first contacting ECWA regarding this matter, I was told that their GPS data showed no changes to my property. However, I have resided at this property my entire life and am familiar with every aspect of it As to the identification of each and every ECWA employee with whom I have been in contact, my primary contact is Molly Methara (sp?) at 716-849-8465. She has assured me that she already has this contact information available to her, and that listing her as the primary contact with ECWA would be sufficient herein for purposes of this claim.

It is my contention that the ECWA is liable for the damage to my property, whether by the leaking water line itself, or by the ECWA's use of my driveway and property to park it's machinery and dig up the ground and remove the tree from my neighbor's property from that position.

Per ECWA's instruction, I have included the following as it relates to this claim:

- 1. A copy of the Notice of Transfer of Ownership of Your Residential Property indicating that I am the owner of record;
- 2. Photographs taken of the damage to my driveway and surrounding area; and
- 3. A copy of an estimate dated April 18, 2024 received from Maggio Construction for repairs in the amount of \$3,810.63.

In light of the above, I hereby make this claim against the Erie County Water Authority in the amount of Three Thousand Eight Hundred Ten Dollars and Sixty-Three Cents (\$3,810.63).
