At the meeting of April 30, 2020, the Board approved a professional service agreement with Raftelis Financial Consultants, Inc. ("Raftelis"). The agreement was for a three-year term with two potential one-year extensions.

The agreement was amended on July 30, 2020 to add a billing rate. Subsequently, on February 2, 2023, the agreement was amended to approve the first extension; this extension expired on March 31, 2024. The agreement was amended on April 17, 2024 to approve the final extension through March 31, 2025.

It has come to my attention that the terms of the contract limit the total expenditure for services to \$170,000. This request is to amend that limit by \$30,000 to \$200,000.

There is a resolution for the meeting of October 17, 2024 approving the execution of an amendment to increase the limit to cover services for the remaining contract period which expires on March 31, 2025. Thank you.

AMENDMENT NO. 4 TO PROFESSIONAL SERVICES AGREEMENT FOR FINANCIAL SERVICES

AMENDMENT, effective October 17, 2024, to the Professional Services Agreement effective on April 9, 2020, by and between

hereinafter referred to as the "Authority," and

RAFTELIS FINANCIAL CONSULTANTS, INC.

hereinafter referred to as "Consultant."

WHEREAS, on April 30, 2020, the Authority awarded the Consultant a professional service contract for financial services including financial planning and rate assessment, as well as debt issuance support for a three-year term, beginning on April 1, 2020 (the "Contract"); and

WHEREAS, on July 30, 2020, the Authority and the Consultant entered into Amendment No. 1 adding a billing rate of \$155 for an Associate; and

WHEREAS, on February 2, 2023, the Authority and the Consultant entered into Amendment No. 2 extending the term of the Contract through March 31, 2024; and

WHEREAS, on April 17, 2024, the Authority and the Consultant entered into Amendment No. 3 extending the term of the Contract through March 31, 2025; and

WHEREAS, the terms of the Contract limit the total expenditure for services to \$170,000; and

WHEREAS, the Authority's Chief Financial Officer and Comptroller recommend that the Authority amend the Contract by increasing the total expenditure for services by \$30,000 to \$200,000; and

WHEREAS, in accordance with Article 3, Paragraph 3.02 of the Contract, any modification or variation from the terms of the Contract must be in writing, authorized by a resolution of the Board of Commissioners of the Authority (the "Board") and signed by all parties; and

NOW, THEREFORE, in consideration of mutual promises herein set forth, the parties agree to the following:

- (1) The parties agree to amend paragraph 2.03 of the Contract to increase the total not to exceed for services by \$30,000, changing the current figure of \$170,000 to \$200,000; and
- (2) The parties agree all other terms and conditions of the Contract shall remain unchanged and in effect; and
- (3) This Amendment may be executed in counterparts, each of which is deemed an original, but all of which together are deemed to be one and the same agreement.
