MP-091 Corrosion Control Program Management

The Engineering Department is requesting the transfer of funds to the 2024 capital budget for the above-referenced project. This budget transfer will ensure that the Authority will be in the best possible position to compete for grant funding through the NYSEFC Water Infrastructure & Improvement (WIIA) program. In order to be eligible for this grant, a funding source must be identified prior to the application deadline on June 14, 2024.

A total of \$8,447,400.00 is being requested to be transferred to Contract MP-091 from Contracts MP-090 (\$6,447,400) and W-030 (\$2,000,000). Funds are available in Contract MP-090 due to the overall construction sequence and anticipated delays in construction and in W-030 due to design delays related to work in National Grid Rights of Way resulting in less construction anticipated to be completed in 2024.
