SUBJECT: Creation of one (1) position of Warehouse Supervisor

The Stores Department is a vital unit of the Authority's organization. It warehouses our extensive inventory of materials necessary to effectively and efficiently perform tasks related to the inspection, service, maintenance and repair of the equipment, water lines and all appurtenances of the distribution system of the Authority. The development of a new Barcoding and Scanning system for all inventory has been underway for some time and will enhance our current Asset Inventory Management System to provide more accurate counts at all inventory locations on a real-time basis. In order to ensure a positive transition to this new system, as well as supervise the workflow within the Stores Department along with the departments it services, I recommend creating one (1) position of Warehouse Supervisor to supervise the operations of the Stores Department and all activities related to the new Asset Inventory Management System.

The title of Warehouse Supervisor will be Salary Grade 29 and has a starting salary of \$76,531.52. I have requested authorization from the Erie County Department of Personnel to add one position of Warehouse Supervisor to the Authority's inventory.

A resolution to approve the creation of one (1) position of Warehouse Supervisor has been included for your consideration at the meeting of October 17, 2024.
