SUBJECT: Support of Federal Legislation to Establish a Permanent Low-Income Household Water Assistance Program

As you are aware, the Low Income Household Water Assistance Program (“LIHWAP”) was established through the consolidated Appropriations Act of 2021 and the American Rescue Plan Act of 2021 with the intent to assist low-income households with the costs of their water and wastewater bills.

LIHWAP was very beneficial to the ECWA customers who applied for assistance. During the entirety of the program, the Authority received payments on behalf of more than 1,200 households totaling \$673,613.06.

At the last Board meeting, Sabrina Figler reported on her recent participation in AWWA’s Fly-In annual event in Washington, D.C. Ms. Figler noted the purpose of the Fly-In is to advance AWWA’s priorities on Capitol Hill by utilizing its vast membership and the influence each member has with their own congressional representatives. One of AWWA’s four legislative priorities is to support the passage of S3830, the LIHWAP Establishment Act, which would establish a permanent low-income water customer assistance program. I am requesting that the Board approve sending the resolution of support to Erie County’s federal delegation to the United States Senate and the United States House of Representatives.

A resolution of support for the passage of the LIHWAP Establishment Act has been included for your consideration at the meeting of May 23, 2024.
