1. ECWA Authorization Form for processing Professional Service Contract Amendment #1 with Arcadis of New York, Inc. (Arcadis).

2. Three original copies of Professional Service Contract Amendment #1 for the above referenced project.

The Amendment is to increase the General Services lump sum fee and adjust the hourly rate for the Resident Inspection (RI), Program Assistance, and Special Services task services for the above referenced project.

On June 16, 2022, the Authority and the Consultant entered into a professional services contract for Program Management relating to EPA's Lead and Copper Rule Revisions. The scope of services included a task for design, general construction, and resident inspection services for contractor replacement of curb boxes (test pits) at 200 customer service line locations. Service line material information obtained during this task (on the resident and ECWA side of the curb box) was entered into the service line predictive model.

The project was bid as unit price contract, and based on the contractor bid, an opportunity to increase the number of curb box replacements is available within the project's original capital budget. The information obtained from the additional curb box replacements will provide additional data for further refinement of the predictive model.

As a result, additional consultant effort beyond that included in the original Professional Services Agreement is required for General Services and Resident Inspection.

The above referenced additional curb box replacements will extend of the duration of the construction contract, requiring an adjustment of the original direct hourly rates for resident inspection as indicated in Table 1. The proposed direct hourly rates for resident inspection have been incorporated into the calculation of the additional fees.

Additional fees included in this amendment to complete the work, utilizing the proposed hourly rate increases for Resident Inspection, are as follows:

- Article 4, § 4.05, Paragraph A.5. Lead Service Line Inventory General Services to increase the lump sum payment by \$35,000, changing the current figure of \$34,650.00 to \$69,650.00.
- Article 4, § 4.05, Paragraph B.2 Resident Inspection to increase the not-to-exceed payment by \$25,000, changing the current figure of \$65,000.00 to \$90,000.00.

The fixed hourly rates for Program Assistance and Special Services will be adjusted at this time as the need for engineering services under these tasks will continue into 2025. Tables 2 and 3 below summarize the rate adjustments under this amendment.

ECWA and the Consultant discussed the level of services that required and associated additional fees. The additional fees requested in this amendment are reasonable and customary and within the original scope of work.

### AMENDMENT NO. 1 PROFESSIONAL SERVICES CONTRACT

AMENDMENT, effective August 15, 2024 ("Amendment No. 1") to the Professional Services Contract (Contract No. MP-091), entered on May 16, 2022, by and between:

#### ERIE COUNTY WATER AUTHORITY

hereinafter referred to as the "Authority," and

### ARCADIS OF NEW YORK, INC.

Key Center at Fountain Plaza 50 Fountain Plaza, Suite 360 Buffalo, New York 14202

hereinafter referred to as the "Engineer."

**WHEREAS,** on June 16, 2022, the Authority and the Engineer entered into a professional services contract for engineering and consulting services relating to program management of the Authority's implementation of the EPA's Lead and Copper Rule Revisions ("LCRR") (the "Contract"); and

WHEREAS, during the scope of services of the Contract included a task for design, general construction, and resident inspection services for contractor replacement of curb boxes (test pits) at 200 customer service line locations; and

WHEREAS, the Authority obtained service line material information from the replacements of the curb boxes that was entered into the service line predictive model; and

**WHEREAS**, the Authority has the opportunity to increase the number of curb box replacements and further refine the predictive model; and

WHEREAS, the Engineer has requested an additional fee of \$35,000 be added to the General Services lump sum, and that the not-to-exceed payment for Resident Inspection be increased by \$25,000, for a total of an additional \$60,000 to complete the additional curb box replacements; and

WHEREAS, the Engineer has also requested an increase in the payable hourly rates for Resident Inspection services, Program Assistance and Special Services; and

WHEREAS, the Authority's Chief Operating Officer and Executive Engineer recommend that the Authority amend the Contract by increasing the lump sum payment for General Services by \$35,000, increasing the not to exceed total for Resident Inspection by \$25,000, and increasing the payable hourly rates for Resident Inspection and Program Assistance and Special Services; and

WHEREAS, in accordance with article 5, paragraph 5.02 of the Contract, no modification or variation from the terms of the Contract shall be effective unless it is in writing and authorized by a resolution of the Board of Commissioners of the Authority (the "Board") and signed by all parties;

**NOW THEREFORE,** in consideration of the mutual promises herein set forth, the parties agree to the following:

- (1) The parties agree to amend article 4, paragraph 4.05, subparagraph (A)(5) to increase the lump sum for General Services by \$35,000, changing the current figure of \$34,650 to \$69,650; and
- (2) The parties agree to delete article 4, paragraph 4.05, subparagraph (B) in its entirety and replace it with the following:

The Dollar amount for Estimated Resident Inspection is based on a fixed hour estimate of 400 hours of Resident Inspector Payable Hourly Rate and 50 hours of Senior Construction Manager Payable Hourly Rate. during the duration of the Project. Payment will be made for actual hours worked during the duration of construction. Actual hours will vary based on production rates of the Contractor during construction, unforeseen circumstances that develop during construction, and weather conditions.
