The Engineering Department is requesting the transfer of funds to the 2024 capital budget for the above referenced watermain replacement project.

Funding is required to account for construction phase services (closeout assistance) and record drawing development which were anticipated to be completed in 2024 but inadvertently omitted from the 2024 capital budget.

A total of \$25,000.00 is being requested to be transferred to Contract DA-011 from Contract WSA-018 – Water Distribution System Improvements, Town of Clarence. Funds are available in this item as the design is complete and the project has been placed on hold.
